Let a Rule Nisi be issued calling upon the respondents No. 1,2 and 4 to 6 to show cause as to why the respondents should not be directed to establish Code Enforcement Authority as per Chapter-2, Code 2.1 of the Bangladesh National Building Code -2006 and further to show cause as to why the respondents should not be directed to secure compliance with the Safety and Security provisions of the Bangladesh National Building Code 2006 at every level of construction and demolition of any building and/or such other or further order or orders passed as to this Court may seem fit and proper.

The Rule is made returnable within 4(four) weeks from date.

The respondents are directed to inform this Court about implementation of the Bangladesh National Building Code 2006 in respect of building construction and demolition at Dhaka and Chittagong cities and submit a report to that extent within 4(four) weeks from date.
